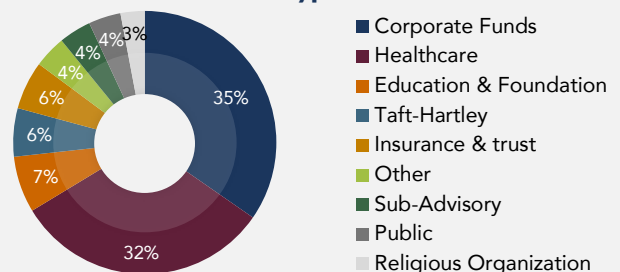
### About Merganser
