Investment Strategy

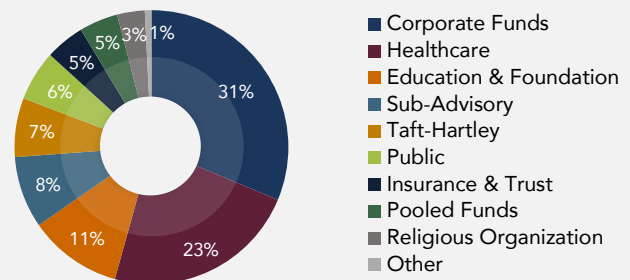
- Leverage our boutique size by investing in underappreciated areas of the market
