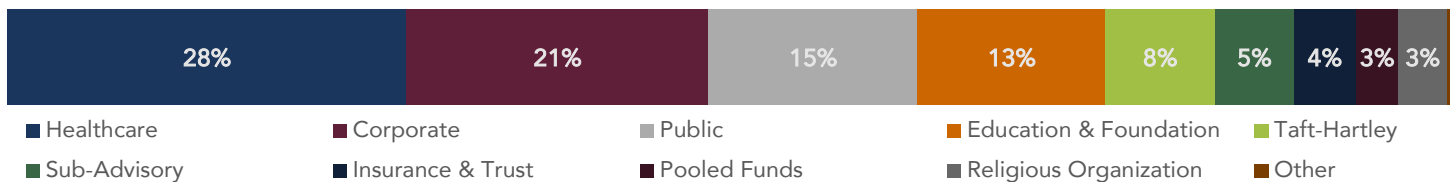

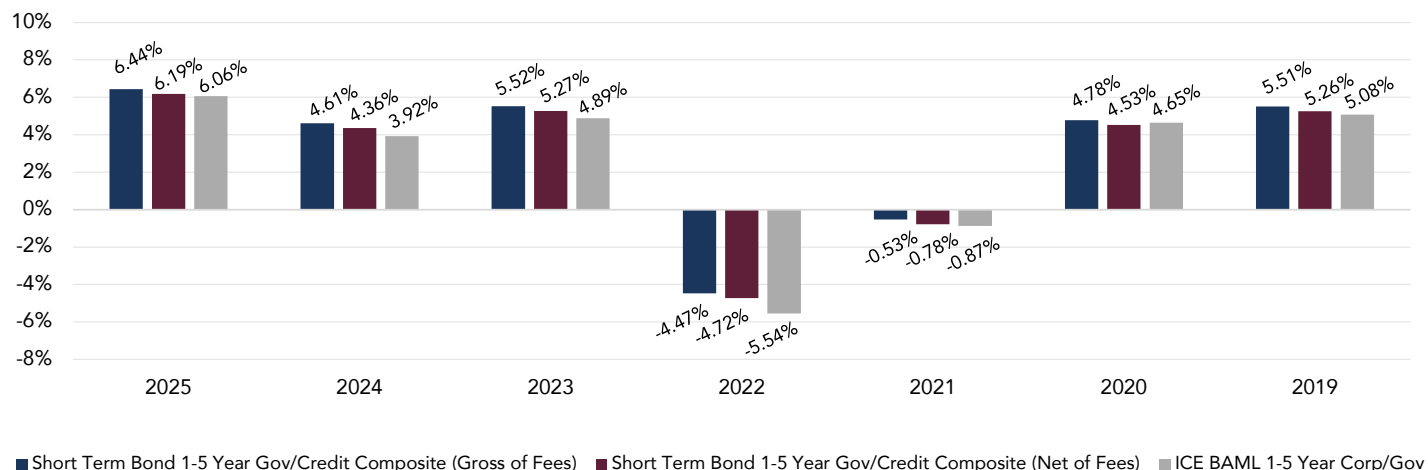

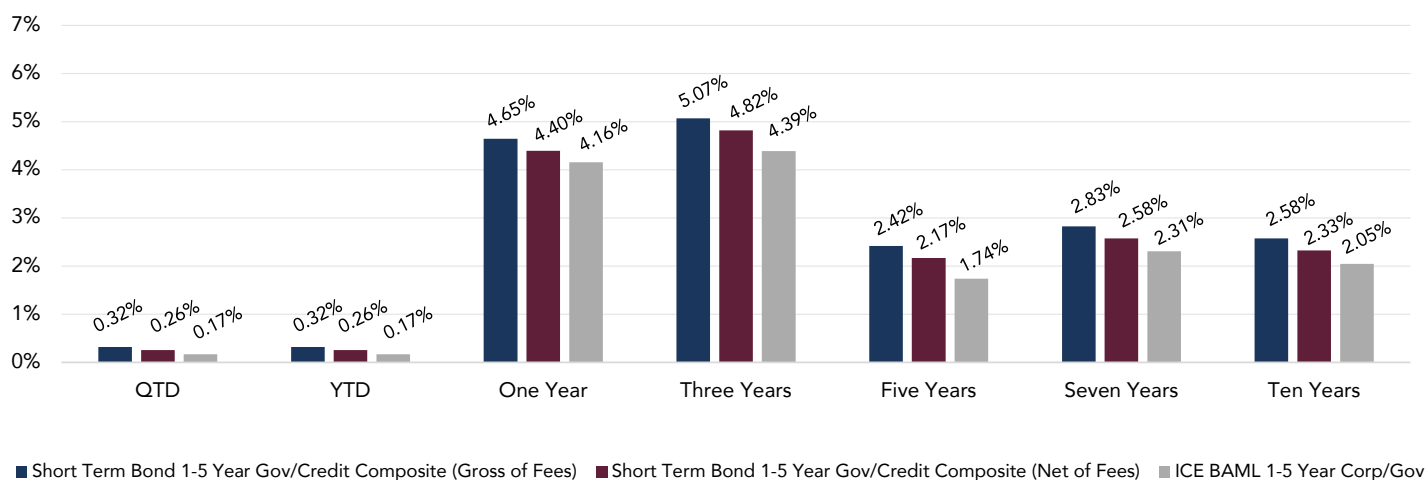


COMPOSITE PERFORMANCE VS. BENCHMARK
